

WEEKLY COMMENTARY 01.27.2024

U.S. Equities

Another round of strong economic data helped propel the US averages higher. The S&P 500 climbed 1.1% this past week, narrowly missing a record close. The Nasdaq Composite gained 0.9% and the Dow Jones rose 0.65% to a new high.

Treasuries

Treasury yields moved higher last week driven by strong economic reports. The 10- and 30-year yields posted a second straight week of gains with the 10-year yield up 1.4 basis points and the 30-year bond yield up 3.5 basis points. The Fed sensitive 2-year note yield climbed 4.1 basis points on the week.

Dollar

The US dollar index moved slightly higher over the week continuing the rally it has been on since the start of the year. The DXY is up 2.1% year to date.

Gold

The price of gold fell again this week losing about 0.5% as risk assets continue to draw investors' attention.

Oil

Oil prices recorded weekly gains supported by US production outages, strong economic data, and geopolitical tensions in the Middle East. WTI gained 6.5% for the week and Brent rose 6.1%.
