

# WEEKLY COMMENTARY 06.01.2024

### **U.S. Equities**

A weaker than expected PCE price index report helped the Dow Jones to its strongest day of the year but all three US averages finished the week with losses. Despite the tough week, it was a winning May, with each of the major benchmarks registering a sixth positive month in seven. US Equities continue to take their direction from the expected timing of Fed rate cuts. The S&P 500 remains in the upward channel it moved into in October.

### **Treasuries**

Treasury yields reacted to the PCE report as well, moving lower and capping off a mixed week for yields. On the week, the 2year rate fell 5.9 basis points, the 10-year rate rose 4.1 basis points and the 30-year bond yield rose 7.6 basis points. For the month of May, all three rates had their biggest one-month decline since last December.

## Dollar

The US Dollar Index continued the downward track it has been on for most of the month, closing out the week down 0.39%. For the month of May the dollar index is down 1.05%, its first monthly decline of 2024.

# GOLD

Gold prices declined over the week but posted their fourth straight monthly gain in May.

### Oil

Oil prices retreated last week as weaker than expected gasoline demand at the start of the summer driving season weighed on prices. Recent price weakness helped both WTI and Brent post their largest monthly declines for 2024 in May.
