U.S. Equities

It was a mixed performance for US equities last week with the S&P 500 and Nasdaq hitting multiple record highs, while the Dow Jones closed out the week down about 0.5%. The S&P 500 now sits above 5400 and the artificial intelligence stocks continue to be the driving force behind the market's advance.

Treasuries

Treasury yields finished the week lower and reached levels not seen since March as softer-than-expected U.S. inflation readings for May boosted expectations for a Federal Reserve interestrate cut as soon as September. For the week, the 2-year note yield fell 18.7 basis points, the 10-year note yield dropped 21.6 basis points and the 30-year bond yield retreated by 19.7 basis points.

Dollar

The US Dollar Index recorded a 0.7% weekly gain and closed at its highest level since May 1.

GOLD

Gold prices scored their first weekly gain in four weeks and finished the five trading sessions up more than 1%.

Oil

After the US Energy Information Administration revised higher its global oil demand growth forecast for 2024, crude prices climbed despite slowing US economic activity. For the week WTI and Brent posted gains of better than 3%.
