

WEEKLY COMMENTARY

U.S. Equities

Softening US economic data over the week helped fuel a rally in risk assets. The Dow Jones closed above 40,000 for only the second time in history, the S&P and Nasdaq closed near record highs. For the week, the Dow led the gainers, jumping more than 1%, followed by the S&P 500 up 0.6% and the Nasdaq higher by .25%.

Treasuries

Treasury yields hit their lowest levels in four or five months as US economic data continues to soften and Friday's University of Michigan consumer sentiment report showed growing concern among US consumers. On the week, the 2-year yield fell 13.9 basis points, the 10-year yield dropped 8.5 basis points and the 30-year bond yield declined 6.7 basis points.

Dollar

The US Dollar Index posted a second consecutive week of declines as the odds of a Federal Reserve rate cut in September have increased.

GOLD

Gold prices closed above \$2,400.00 an ounce on Friday and continued the upward move it's been in since late June. The likelihood of upcoming rate cuts by global central banks has improved the opportunity cost of holding the yellow metal.

Oil

Oil prices posted their first weekly loss in five weeks as traders weighed this week's U.S. inflation data but found some support in weakening supply numbers. WTI was 1.1% lower for the week while Brent fell 1.7%.
