

# WEEKLY COMMENTARY 08.03.2024

# **U.S. Equities**

A weak manufacturing report on Thursday and a rise in the unemployment number on Friday sent stocks into a freefall after the major averages reached record highs in July. Over the last two trading sessions of the week the S&P 500 fell 2.8%, the Nasdaq Composite dipped 4.54% and the Dow Jones declined 2.42%. The Nasdaq has now entered correction territory. The S&P 500 and Dow posted weekly losses of 2.1%.

# **Treasuries**

Treasury yields, which were already moving lower after the FOMC meeting on Wednesday, continued to be pressured by the weak economic news. On the week the 2-year note yield dropped 51.7 basis points to reach its lowest level since March 2023. The 10-year note yield closed at its lowest level since December 27, 2023, and the 30-year bond yield settled at its lowest level since February 1.

### Dollar

The US Dollar Index sunk to a four-month low as a more dovish Fed and a rate hike by the Bank of Japan put pressure on the greenback.

# GOLD

Gold prices touched a record high on Friday before backing off to close the week 3.7% higher. The increasing odds of a rate cut by the Fed has supported gold prices this year.

# Oil

Oil prices ended lower on the week, posting a fourth straight weekly decline as worries about the demand outlook in both China and the U.S. overshadowed fears of a wider Middle Eastern conflict. WTI slipped 4.7% and Brent slid 4.3% on the week. Peter Conniff Head Trader
