

WEEKLY COMMENTARY

U.S. Equities

Well, it's September and stocks are acting like it. All three major indices fell during the week, weighed down by concerns of an economic slowdown and tech selloff. For the week, the S&P 500 lost about 4%, marking its worst week since March 2023. The Nasdaq sank 5.6% to book its worst start to September since 2001. The Dow slipped 2.5% and posted its steepest early-September decline since 2008.

Treasuries

Treasury yields fell on the week as jobs data continued to show weakness in the US economy and some Fed members signaled the possibility of a 50-basis point cut in rates later this month. For the week, the 2-year note yield fell 27.5 basis points, the 10-year note slipped 20 basis points, and the 30-year bond yield dropped 17.6 basis points.

Dollar

The US Dollar Index approached a thirteen-month low during the past week and was down 0.8% over the five trading sessions.

GOLD

Another volatile week for gold saw the price of the precious metal fall below \$2,500.00 an ounce on Friday. Gold closed the week down around 0.2%.

Oil

Oil markets remain under pressure as the fear of a global slowdown in demand grows. West Texas Intermediate crude reached its lowest level since June of 2023, down 8% on the week. While Brent prices lost 7.2% on the week.
