

WEEKLY COMMENTARY 01.31.2025

U.S. Equities

The S&P 500 and Nasdaq composite posted losses for the week as technology stocks were rattled by news that Chinese startup DeepSeek was producing a cheaper AI chip than its American competitors. The Dow Jones managed to hang onto gain in what turnout to be a volatile last week on the month. All three indices posted gains in January with the Dow Jones posting its best month since 2019.

Treasuries

Treasury bond yields rose on Friday after a spokeswoman for President Donald Trump confirmed that U.S. tariffs on Canada, Mexico and China would go into effect on February 1 but finished the week mixed. For the week, the 2-year note yield fell 1.4 basis points, the 10-year yield declined by 1.1 basis points, but the 30year bond rate rose 2.7 basis points.

Dollar

The US dollar weakened over the last five trading days as the FOMC held interest rates steady and Core PCE came in lower-than-expected suggestion the Fed may still cut rates twice this year.

GOLD

Gold prices increased again this week, reaching an all-time high on Friday. The yellow metal posted a weekly gain of 2.9% lifted by weakening dollar and flight to safety trade.

Oil

Oil prices declined over the week but recorded gains for the month of January as traders awaited the impact of proposed tariffs. West Texas Intermediate crude fell 2.9% in the week and Brent declined by 2.2%.
