

WEEKLY COMMENTARY 02.07.2025

U.S. Equities

The continued talk of tariffs overhung the market and stocks finished the week mixed. The S&P 500 and Nasdaq posted slight gains while the Dow Jones fell a quarter of a point in the week. The S&P 500 did manage to close above the 6000 level.

Treasuries

Treasury bond yields were mixed throughout the week as bond investors struggled to interpret US economic data and the status of the Trump tariff plan. The 2-year note yield rose 4.2 basis points during the week, but the 10-year note yield fell 8.3 basis points and the 30-year bond rate dropped by 12.4 basis points.

Dollar

The US dollar index closed lower for the week.

GOLD

Gold prices spend most of the week above \$2850 an ounce and remain near record highs as global central banks easy interest rates.

Oil

Oil prices declined for a third straight week amid rising US inventories and worries that a trade war will slow global growth. WTI was down 2.1% for the week and Brent posted a weekly loss of 1.3%.
