

WEEKLY COMMENTARY

U.S. Equities

All three major US indices posted weekly losses with the Dow Jones recording its biggest one-day loss of 2025 on Friday, after readings on consumer sentiment and the economy weakened. On the week, the S&P 500 dropped by 1.6%, while the Dow and Nasdaq slipped 2.5% and 2.4%, respectively.

Treasuries

Treasury bond yields fell across all maturities last week as investors began to question US economic growth prospects. The minutes of the FOMC's January meeting suggested the Fed is in no hurry to move rates from their current levels, adding to the uncertainty in the Treasury market. The benchmark 10-year yield ended the week at 4.43%.

Dollar

The US dollar index fell for a third straight week and touched levels not seen since last December. The greenback weakened against a basket of currencies as Treasury yields continued to slide.

GOLD

Gold prices posted their eighth straight week of gains and remain near record highs.

Oil

Oil prices ended the week approximately where they started the week with WTI and Brent down 0.4%. The uncertainty surrounding talks to end the Ukraine/ Russian war and supply concerns helped support the price of crude offsetting a slowing US economy.
