## **U.S. Equities**

Despite a technology-led rally on Friday the major US indices finished a tough week lower. The S&P 500 and Nasdaq fell over 2% each for the week while the Dow Jones declined by 1.3%, its worst week since March 2023.

### Treasuries

Treasury bond yields were rangebound this week as investors look to next week's FOMC meeting. The yield on the 2-year note was up 1.5 basis points on the week with the 10- and 30- year bond yields flat.

### Dollar

The US dollar index ended the week flat as traders debate the strength of the US economy and the direction of interest rates.

## GOLD

Gold prices touched \$3,000.00 an ounce on Friday before backing off slightly to the \$2980 level. The precious metal posted a weekly gain of 3% and closed at a record high.
